CCPA and Beyond

The California Consumer Protection Act took effect at the beginning of 2020, and the legislation places a great emphasis on the rights of consumers and their data. It requires, among other things, that businesses “inform consumers about the data collected and shared, and gives them a right to access, to delete, and to opt-out.”¹ And while the California regulations are what everyone is currently discussing, numerous other states are in the process of rolling out their own privacy legislation.

Compliance can be a large burden. You need to be absolutely certain that you’re tracking all the data you’ve collected on your customers, so when they make a data subject access request (also called data subject lookup), you can quickly and easily respond to their requests.

However, many companies struggle with a centralized view of their data that can be queried in a timely manner, putting them at risk for violating the CCPA. A recent Gartner survey found that processing each request costs organizations more than \$1,400 on average, in addition to taking more than two weeks to respond. That time and money can add up, but you don’t have to handle compliance on your own.

When receiving a customer data request, you can have peace of mind knowing that you’ll quickly return all data collected on them because it’s securely connected, consolidated, and easily retrievable.

How It Works

Easily upload your customer lists as a batch or via API. This includes emails, name, address, Placekey ID, phone, mobile advertising IDs, and hashed emails.

FullContact matches each to an individual ID. When different inputs match to the same person, the same persistent ID is assigned that same ID—that way you know *email 1* and *email 2* belong to the same individual.

Our privacy compliance solution works via API, meaning if you get a customer request, you can immediately jump into action to recall that person's information.

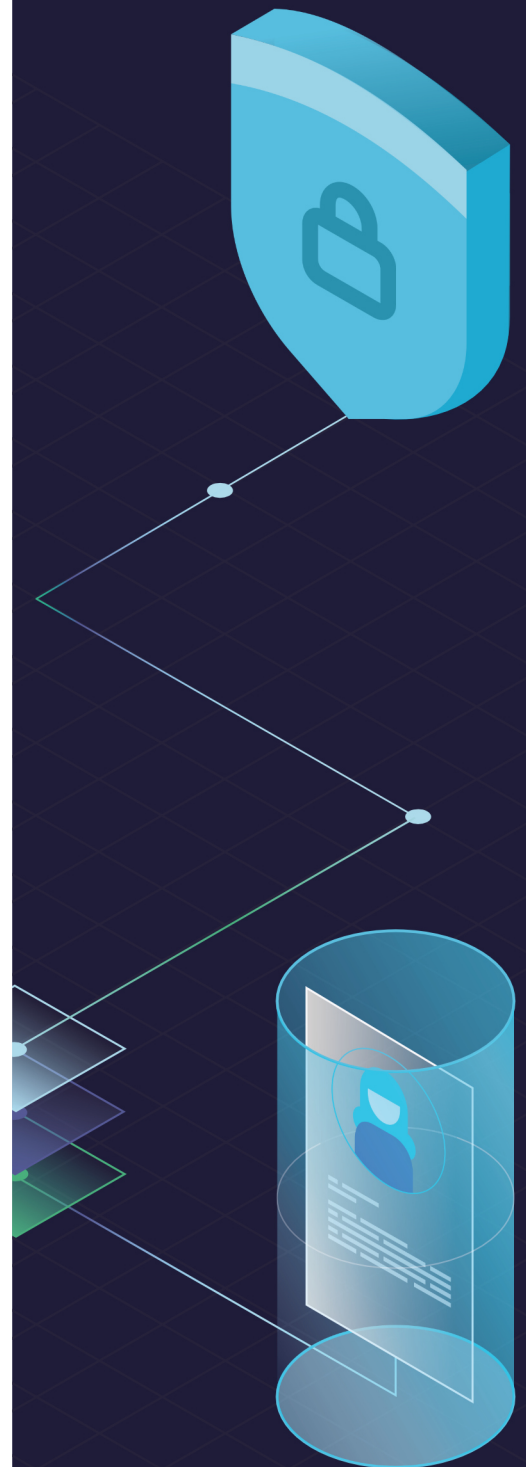


Real Preparedness
